**WAGE INCREASES:** Moved by Smith, seconded by Jostock to approve the adjustment of Assessor Salary as \$14,200.00 annually beginning July 1, 2021. Motion carried unanimously.

**MILLAGE RATE:** Treasurer Skovran informed the board that the millage rate for Lapeer County is 3.6654.

**PUBLIC SAFETY ASSESSMENT BUDGET RESOLUTION:** Moved by Jostock, seconded by Smith to accept the Arcadia Township Resolution concerning Public Safety Special Assessment Budget.

**PUBLIC HEARING FOR 2021/2022 BUDGET:** The Arcadia Township Board reviewed the budget. The Budget was prepared with proposed 1.3450 millage rate.
