

**ARCADIA TOWNSHIP
REGULAR BOARD MEETING
September 09, 2025**

The regular meeting of the Arcadia Township Board was held on Tuesday September 09, 2025, at 7:30 p.m. at the Arcadia Township Hall, 4900 Spencer Street, Lum, Michigan.

Supervisor Lashbrook called the meeting to order at 7:30 p.m. with the following members present: Supervisor Lashbrook, Clerk Poniatowski, Treasurer Skovran and Trustee Howell. Trustee Howe was absent.

AGENDA: Moved by Howell, seconded by Skovran to approve the agenda as presented. Motion carried.

MINUTES OF AUGUST 12, 2025: Moved by Poniatowski, seconded by Howell to approve the August 12, 2025 meeting minutes as presented. Motion carried.

PUBLIC TIME: Resident Ray Swain spoke commending the patch job on Mitchell Lake Road. Resident Eric Hood expressed concern regarding the condition of his driveway.

REPORTS:

POLICE REPORT/ORDINANCE ENFORCEMENT: Officer Poniatowski reported 45 calls and 9 traffic stops for the month of August.

BUILDING PERMITS: There were two new permits and two final permits issued for the month of August.

FIRE DEPARTMENT: Arcadia Township Fire Chief Lee reported 4 fire runs for the Arcadia Township Fire Department since our last meeting.

CEMETERY REPORT: Sexton Steve Nihranz reported three cremation burials for the month of August.

COUNTY COMMISSION REPORT: County Commissioner Ian Kempf was not available for a report.

ROADS: Discussion was held on the roads.

BILLS AND VOUCHERS: Moved by Skovran, seconded by Howell to approve the bills and vouchers including check #'s 33795-33841 in the amount of \$140,544.32 excluding check # 33839. Motion carried.

BUDGET REVIEW: Moved by Poniatowski, seconded by Skovran to approve the budget for the month of August. Motion carried.

TREASURER REPORT: Moved by Skovran, seconded by Poniatowski to approve the August 31, 2025 treasurer's report as presented. Motion carried.

BOARD COMMENTS: The respective representatives gave a brief synopsis, if available, of the Planning Commission, ZBA, Construction Code Authority, MTA, Lapeer County Road Commission and EMS.
